



## Guardian Fence System® Product Warranty

This warranty covers the **Guardian Fence System®**, manufactured by Betafence USA LLC (hereafter referred to as "Betafence USA"), and is valid only to the original fence purchaser in the original installation location. Materials and workmanship are guaranteed under normal and proper usage against structural defects in the framework of posts, rails, and brackets for a period up to 10 years. The galvanized and powder coat finish is warranted against cracking, peeling, chipping, corrosion or blistering for a period of up to 10 years from the original purchase date.

Should the fence framework manufactured by Betafence USA fail in accordance with any of the above conditions, Betafence USA warrants to the original purchaser their redemption through replacement, repair, renewal or issuance of a pro-rated credit. The decision as to which method of redemption allowed is solely at the discretion of Betafence USA. If pro-rated allowance is the chosen alternative, the amount will be based on the total time under warranty from date of purchase to date of claim, and on the original cost of framing materials found to be defective. All claims under the conditions of this warranty shall be sent to Betafence USA, in writing within 30 days of observation of such, together with photographs, proof of purchase and samples if requested, and shall specify the nature of the defect and when it was first observed. Claims should be submitted to: Customer Warranty Service, Betafence USA LLC, 3309 S. I-45, Ennis, TX 75119. Betafence USA reserves the right to inspect the material to determine validity of the claim.

Covered by this warranty is the material and manufacturing of products as originally installed. Should the fence be improperly installed or moved after original installation, Betafence USA shall not be responsible for the performance or appearance of the material. The warranty is void if parts or components not supplied by Betafence USA are used in the installation of the fence. This warranty does not cover failure or damage due to improper use or application, soil or structural movement, abuse or misuse, vandalism, negligence, failure to perform proper routine maintenance or acts of God. Normal and proper usage does not include damage caused by installation within 20 miles of coastland, impact, external forces, physical damage, abrasion, landscape damage or residue, or exposure to acid rain, irrigation chemicals, abnormally high levels of airborne pollutants, or salty environments. Evidence of exposure of the fence products to salt or salt spray voids this warranty.

Upon validation of a claim by Betafence USA, the company will decide redemption by replacement, repair, renewal or issuance of a pro-rated credit. Reimbursement for the costs of removal, installation or shipping of materials is not included in this warranty, nor will Betafence USA provide those services. Betafence USA will not be liable for incidental, special or consequential damages.

The above constitutes the complete warranty by the manufacturer. **NO OTHER AGREEMENT, EXPRESS OR IMPLIED, IS VALID, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND NO TERMS OR CONDITIONS OTHER THAN THOSE STATED HEREIN SHALL BE BINDING ON BETAFENCE USA.** Betafence USA does not authorize any other person or agent to make any other express warranties. Betafence USA neither assumes nor authorizes any other person or agent to assume any other liability in connection with Betafence USA. Some jurisdictions do not allow limitations on how long an implied warranty lasts, nor do they allow an exclusion or limitation of incidental or consequential damages; therefore, the limitations and exclusions noted herein may not apply.

A copy of this warranty must be received by Betafence USA LLC within 30 days of completion of installation to validate warranty.
